- 5. The permission will operate for 2009-2010 only it the requirement of 180 teaching days in the session be fulfilled as per calendar of the University/Affiliating Body.
- The institution shall, within one month of the receipt of recognition order, convert the
 endowment fund and reserve fund account into a joint account to be operated along with an
 officer of the Western Regional Committee.
- The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- 8. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2007.

- 13. If the institution contravenes any of the above conditions or the provisions of the NCTL Act. Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
- 14. Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1. Bahadur Shah Zafar Marg. Near ITO, New Delhi- 110002 against this order under section 18 of the NCTE Act. 1993 within 60 days of the issue of this order. The guidelines of appeal are enclosed herewith.
