- III. Sensitization workshops for teachers and staff

8. Crisis Management

- I. Immediate support and referral in cases of emotional distress
- II. Suicide prevention protocols
- III. Coordination with parents/guardians where necessary

9. Confidentiality

All mental health-related information shall be handled with strict confidentiality and sensitivity.

10. Review and Monitoring

This policy shall be reviewed and updated annually by the Mental Health Committee.
